Report Monitoring Key Events and Public Sentiment

### "Al Aqsa Flood" Protocol

- Continuous displacement of several civilians from displacement centers and families
  who returned to their homes in the northern Gaza Strip, heading south via Al-Shid Street,
  due to a shortage of basic products and materials.
- Active movement of displaced persons around the shelters from morning until 7:00 PM.
- Continued reduction of civilian movement in border areas.
- Medium-level movement of civilians inside Beit Hanoun was noted, especially near the shelters, in light of the intensified Zionist strikes on the houses.
- There is significant movement in the areas of Beit Lahia and eastern Jabaliya to harvest agricultural produce, alongside the fear of being attacked by the occupation forces.
- Continued presence of some civilians in their homes during the day and their return to the shelters at night.

#### **Market and Goods Activities**

- Products from the markets and traders' warehouses disappear, which are stored in unknown locations (hiding places), with only limited quantities being released to achieve the highest possible prices and ensure the security apparatus does not confiscate them.
- Movement, in coordination with several merchants, established sales points for flour and sugar at regular prices, but in very limited quantities that did not meet the civilians' needs.
- Drastic rise in the prices of basic goods, such as: one kilogram of flour 50 shekels, one kilogram of rice — 80 shekels, one kilogram of sugar — 26 shekels, as well as a significant increase in fuel prices (diesel, gasoline, and gas).
- Some fishermen currently fishing in the sea sell one kilogram of fish for 100 shekels.
- Some residents intending to move south (to the southern Gaza Strip) are purchasing goods offered there to engage in trade and earn money. Examples: coffee, lighters, and diapers.

### **Internal Movement (Morale) of Hamas Members**

- A conversation was documented among several members of the organization (Hamas operatives) in Beit Hanoun supporting participation in demonstrations against the Hamas movement and demanding increased efforts for a ceasefire and the entry of aid.
- A rumor is circulating among members of the organization regarding Hamas' inability to manage the crisis due to the lack of control over prices, inability to pursue merchants, and that some members of the organization are committing offenses, the most prominent of which is "theft."

- Several members of the organization continue to curse and condemn the movement, claiming that the movement is the primary cause of the destruction in the Gaza Strip and the deterioration of living conditions.
- Dissatisfaction with the performance of the political wing of the movement, as well as anger over the performance of the police and the government (bodies within Gaza).

Subject: Report on the Confiscation of Humanitarian Aid Belonging to Me and My Brother

I hope this letter finds you in good health and peace.

Regarding the above subject – on Wednesday, 06.03.2024, at 11:00 in the morning, a unit from the Ministry of Interior and Security (Hamas), dressed in civilian clothing, arrived at the home of my brother, the civilian Amer Idris, located in the Al-Rimal area west of UNRWA (...).

The force confiscated 17 sacks of flour and 15 aid coupons that were in a truck owned by him. These were aid items purchased by my brother Amer Idris from the city of Rafah, with each sack sold for 50 NIS. This aid was intended for me, my cousins, and my brothers. We are in possession of a complete list of the names of the intended aid recipients.

I express my hope that the confiscated aid will be returned to its rightful owners.

Subject: Organizing a Protest Against Rising Prices and Harsh Living Conditions

First, we send you our warmest greetings and ask Allah to reward your efforts greatly.

With reference to the above subject, we received information about several civilians who gathered inside the Halima Al-Saadiya shelter center.

- On Thursday, 22/2/2024, at 11:00, a gathering of several civilians and displaced persons took place in the courtyard of the Halima Al-Saadiya shelter center in the Al-Nazla area.
- The demonstrators cursed and blamed the monopolistic merchants, the government, and the security bodies for collusion and cooperation with the merchants.
- The head of the administrative body of the Hamas movement in the Al-Nazla area came down to the civilians and spoke with them in an attempt to calm and understand them, with the assistance of brothers from the Emergency Committee, the General Security Service, and the community works department.

## **Key Findings:**

- 1. Instances of civilians gathering inside shelter centers and participating in popular demonstrations due to the unavailability of basic goods and the insane rise in prices.
- 2. Suspects with a background in the security apparatus were identified who attempted to exploit the gathering and distort it by inciting against Hamas and the government.

3. Some merchants were documented hoarding goods and food supplies, identified as having ties with the government and the movement (i.e., Hamas) leadership, and will not be punished by the governmental authorities.

### Recommendations:

- ✓ Monitor and identify security suspects who tried to exploit the protests and public anger over the cost of living.
- ✓ Penalize merchants who hoard food and raise prices.
- ✓ Strengthen the role of the General Investigations Department in enforcing market pricing.

2.		<ul> <li>Following the formation of Mohammad Mustafa's government – Ramallah – we received an urgent directive from the brothers to coordinate with the West Bank, including for the interest of the Gaza Strip and its civilians.</li> <li>There is now full coordination between the southern and northern Gaza Strip for all components of governmental work.</li> </ul>
3.	Monitoring	- The need was emphasized to submit the names of the wounded who benefited from previous financial payments.

- The list of candidates to receive an electric scooter must be submitted, in accordance with prior correspondence received.
- The administrative and financial report must be submitted in accordance with the forms you received.
- Closure of financial payments designated for the salaries of the movement (Hamas) employees.
- Recommendation of names of widows for the Martyrs' Sponsorship Project who are not employed. Some projects overlap with the Al-Nour Association; therefore, we emphasize the need for coordination between the institutions and the Al-Nour Association in projects specific to martyrs and widows affiliated with the movement (Hamas).
- Recommendation of names of prisoners from the approved list (note: referring to those authorized) for the Al-Nour Association.
- The civil registry program (Takamul)

4.	Update – Numbers/Quantities	- We previously requested updates on quantities in the areas (locals/residents and displaced persons).

		<ul> <li>Regional experiences in carrying out statistical work were presented.</li> </ul>
